## **Terms and Conditions**

Pre-order for Galaxy S9/S9+

- 1. These Terms and Conditions comprise an offer to Samsung customers to benefit from a pre-order and purchase request to Samsung mobile phones (the "Pre-Order", "Offer") during the period between the 26<sup>th</sup> of February 2018 until the 15<sup>th</sup> of March 2018 (the "Validity Period").

- 3. This Pre-Order is only valid for Samsung Galaxy S9 (256GB); and Samsung Galaxy S9+ (256GB) (the "Device(s)").
- 4. A Pre-order Confirmation ("Confirmation") receipt shall be provided to the pre-ordering customer upon full payment of the Recommended Retail Price of the Devices in KSA Saudi Riyal (SAR) as advised by Samsung (the "Pre-Order Amount").
